



CRI Wins HHS MATOC

McLean, VA – March 2015 – Communications Resource, Inc. (CRI) Wins Department of Health and Human Services Multiple Award Task Order Contract (MATOC) to provide physical security and security system integration support services throughout the federal marketplace

The Department of Health and Human Services (DHHS) recently awarded CRI a MATOC to provide physical security and security system integration support services to federal agencies. This includes state-of-the-art electronic and information security. The contract, awarded by HHS through its Program Support Center (PSC), came through the General Services Administration (GSA) Multiple Award Schedules Federal Supply Schedule (FSS) for the PSC. It is a base year contract with four one-year options. It is open to all federal government customers enabling access to CRI's security support services through GSA Schedules 70 and 84. The total value of the MATOC is \$500 million and individual purchase orders are limited to \$50 million. Services are shown below.
